**Green Stringy Leave-on Slime Mask for the Face / Packaging: Jar**

pH: 5.0

**VISCOSITIES:** 1M at RT: 83,400 mPa.s Brookfield LV4-6 /

**Recovery at RT (after 1M at 45°C):** 73,200 mPa.s Brookfield LV4-6.

**STABILITY:** 1M at RT & 45°C.

**FORMULATION ADVICES: Laboratory scale - 200 g**

Heat the water of phase A. Add 50% of the water to the matcha tea. Shake under defoeculation. Add the cornflor and stir with a spatula while maintaining a temperature of 75 °C to obtain a thick texture. Melt at 60 °C phase C. Add phase D, homogenize with a spatula and then pour the remaining 50% of water from phase A and make a gel-cream. Add the phase (A + B) to the cream gel. Before cooling add phase E.
