Challenge test: Criteria A

pH: 5.23/ **VISCOSITIES:** **1M** at RT: 2399 mPa.s Brookfield LV64-V6 /

Recovery at RT (after 1M at 45°C): 2799 mPa.s Brookfield LV64-V6.

STABILITY: 1M at RT, 45°C, cycles -5°C/+40°C.

FORMULATION ADVICES: Laboratory scale - 300 g - Homogenizer

Combine Phase A and heat to 50C to melt Oligogeline and then neutralize with phase B to pH -5. While mixing the batch with high shear, add phase C and mix until Sepimax Zen is completely swelled. Combine phase D and pour it into phase ABC under high shear. Then homogenize the batch for 4 minutes at 4,000 rpm. Check and adjust to pH 5-5.5.
